TENDER NOTICE

Sealed Tenders are invited from bonafide eligible Tenderers for the supply of 10000 No. (Ten Thousand), Block Trays 100cc capacity & 20 Tons of vermiculite for raising plants of Clonal Eucalyptus(Safeda) under the following term and conditions: -

1. The rates quoted in the Tender Application Form enclosed with the Notice along with the Terms and Conditions of the Tender duly signed by the tenderer enclosed in the sealed Tender shall be deposited in the Tender box kept in the office of DFO, CFP, Kurukshetra before 28/12/2011 at 12:00 noon and will be opened at 12:30 PM on the same date by DFO, CFP or official authorized by him in the presence of quotationer or their representatives. Tender forms may be obtained from the office of the DFO, CFP of Forests on payment of Rs. 500/- on or before 11.00AM on 28/12/2011. Along with the downloaded forms Draft of Rs. 500/- from any nationalized bank payable at Kurukshetra to be deposited.
2. The Tenderer shall deposit EMD for the amount indicated against each item in the **Tender Application Form** in the form of Bank Draft or Deposit at Call from any of the Nationalized Bank payable at Kurukshetra in favour of DFO, CFP, Kurukshetra.
3. Tender not accompanied by EMD shall be summarily rejected.
4. The Tenderer shall complete the supply of stores/ work within 15 days from the date of issue of Order.
5. In case of failure on the part of the Tenderer to complete the work/ supply the stores within the stipulated period of time, the EMD so deposited by him/her shall be forfeited to the Govt. account and the work will be got done at his/her risk and cost.
6. The work completed/ stores supplied shall be inspected by the DFO, CFP, Kurukshetra or his representative.
7. The payment shall be released after due verification by the DFO, CFP, Kurukshetra or his representative.
8. In case of any dispute, the decision of the Conservator of Forests will be final and binding on both the parties.
9. All disputes shall be subject to the jurisdiction of the appropriate court in kurukshetra.
10. The DFO, CFP reserves the right to cancel any or all the Tender without assigning any reason thereof.
11. Tenderer shall submit the copy of the PAN card and TIN number duly attested by Gazetted officer along with the Tender.
12. The bids should be accompanied by a sample of material to be supplied. tender not accompanied by the sample shall be summarily rejected.
